Veteran Spotlight

Ted S. Baca

Utah State Commander, Veterans of Underage Military Service.

I was born in Holbrook, Arizona on 20 June 1932. My parents were originally from New Mexico. I was at the age of 15 when all of my buddies started getting the "Army Bug". I didn't want to be left out, I wanted to go too. The next thing I knew, we were at the recruiting station in Flagstaff, Arizona. One of my buddies even wanted to tell on me, but he didn't have to. I was 5 feet, 4 inches and weighed 111 pounds soaking wet with a pocket full of rocks. The recruiter took one look at me and told me to go home and eat a lot of bananas, so I did.

One month later, I went back to Flagstaff. This time they just asked me how much I weighed. I told them 135 pounds. So they said yes. I went through the line and passed everything until they asked for my birth certificate. Well, I didn't have one. I told them I was 17, but they wanted my Mother and Father's permission and proof of birth. So, here I go again, back home to Holbrook.

I got home and told my parents what was going on, and what I needed. Neither of them liked the idea. My Mom said I was too young, that I was only a baby. But we were having a hard time at home. My Father was not working, and I wanted to help. I told them I would send my pay home to them. So two months after I turned 16, my Dad said I could go, and there I went. At this time World War II was over, and my Mother was very sure that there was not going to be another war for a hundred years. This convinced her to say yes.

I returned to Flagstaff and was sworn into the Army on 4 September 1948. I was sent to Fort Ord, California for basic training. When we finished boot camp on 1 December 1948, most of my buddies were sent to Seattle Washington while we were waiting to ship. This went on for about 2 months. We were asked who wanted to go to the Far East, all hands went up. We were all getting webbed feet in Seattle.

Some of my friends went to the 24th Infantry Division, and the rest of us went to the 865th Antiaircraft Artillery Battalion. I was assigned to D Battery of the 865th in January 1949.

In July 1950, we were loaded on LST's and sent to Korea. D Battery was the first unit of the 865th to land in Korea. By this time, I was a Corporal. Within two months, I became a Sergeant-in-charge of two half-tracks, one armed with squad '50's and one with 40mm cannons. I was section chief. We went from Pusan to Pyongyang to the Yalu River and back. We provided support to the 24th and 25th Infantry Divisions and the 1st Cavalry Division, guarding bridges and tunnels in North Korea. D Battery was the only unit of the 865th to see combat in North Korea.

We were at Kimpo (K-14) when we were informed that our enlistments had been extended for one year, the "Truman Year". I served in the 865th until December 1951.

At Age 19, I was discharged at Ford Devlin, Massachusetts, as a Staff Sergeant. I received the Korean Service Medal with three battle stars, the Japanese Occupation Medal and the Korean Presidential Unit Citation.

Saturday, July 28, 2018 at 4 PM at the Ivins City Cemetery, the American Legion Honor Guard provided the Military Funeral Honors for Kelly Tyson "Squid" Coulson a veteran of the U.S. Navy. The American Legion Honor Guard provided the Firing Party as well as the Bugler who played "Taps" for this ceremony. Thirteen (13) Legionnaires reported for duty at this Military Honors Funeral Ceremony. The Firing Party fired their weapons on cue and sounded terrific with the synchronized opening and closing of the seven rifle bolts. Gerald Grosegner of Post 142 handled the Bugler duty and the Bugle Call of "Taps" has never sounded better. The Casket Flag was expertly folded by Don Raymond and by Foster Johnson, the "Fold" was precise and tight. The folded flag was presented to the next of kin by the Commander of the Honor Guard, Foster Johnson.

This Military Funeral Honors Ceremony was in my opinion, one of the best over all ceremonies our Honor Guard has ever done. After the ceremony, several of the family and friends of the deceased veteran expressed their heartfelt gratitude to various members of the American Legion Honor Guard for honoring their loved one. The Mortuary of Record was Pine View Mortuary.

Tuesday, July 24, 2018 at 0730 hours at the LDS Church on Valley View Drive in St. George the American Legion Color Guard participated in the Pioneer Day Breakfast Event put on by this LDS Church. Six Legionnaires reported for duty led by Foster Johnson who was the NCOIC of the Color Guard. Legionnaires participating in addition to Foster Johnson were Marti Bigbie, Bob Stevens, C.J. Iacona, and Terry Dunne. Bodie Bodenhamer handled the Bugler duty and played "To The Colors".

Monday, July 23, 2018 at the Issac W. Carling Memorial Park Cemetery in Colorado City, Arizona at 1:15 PM Mountain Daylight Saving Time the American Legion Honor Guard augmented the Utah Army National Guard Honor Guard providing the Military Funeral Honors for Alvin Issac Black a U.S. Army Veteran who served in the War in Vietnam. The American Legion Honor Guard provided the Firing Party and the Bugler who played "Taps" for this Military Honors Funeral Ceremony. Seven (7) Legionnaires reported for duty and made the 120 mile round trip drive to Colorado City, Arizona from St. George, Utah.

The two (2) Utah Army National Guard Honor Guardsmen were Sgt. Ty Delambert and Sgt. Darrell Adamson and they expertly folded the Casket Flag. The folded Casket Flag was presented to the next of kin by the detail NCOIC Sgt. Ty Delambert. The mortuary of record was Spilsbury Mortuary of St. George, Utah.

Saturday, July 21, 2018 at 12:15 PM at the St. George Tonaquint Cemetery the American Legion Honor Guard augmented the Utah Army National Guard Honor Guard providing the Military Funeral Honors for Maurice "Morris" Vernon Wilson a 100 year old U.S. Army veteran of World War Two. The American Legion Honor Guard provided the Firing Party as well as the Bugler who played "Taps" for this ceremony. Nine (9) Legionnaires reported for duty at this Military Honors Ceremony. The Utah Army National Guard Honor Guard detail of Specialist 4th. Class Tyler Smith and Specialist 4th. Class Tori Taubgo expertly folded the Casket Flag. The folded Casket Flag was presented to the next of kin by American Legion Honor Guard NCOIC Foster Johnson.

As Maurice "Morris" Wilson was a Legionnaire, a Resolution of Transfer to Post Everlasting was prepared by Commander Marti Bigbie. The Resolution of Transfer was read and presented to the next of kin by Vice Commander Terry Dunne. The Mortuary of record was Metcalf Mortuary of St. George, Utah.

Saturday, July 21, 2018 at 9 AM at the St. George Tonaquint Cemetery, the American Legion Honor Guard augmented the Utah Army National Guard Honor Guard providing the Military Funeral Honors for Gary Eugene Salisbury a U.S. Army veteran. The Utah Army National Guard Honor Guard detail members were 2nd. Lieutenant Kenneth Hart and Specialist 4th. Class Tyler Smith. The American Legion Honor Guard provided the Firing Party and the Bugler who played "Taps" for this ceremony. Twelve (12) Legionnaires reported for duty at this Military Honors Funeral Ceremony. The Casket Flag was folded by 5 members of the Dixie High School Air Force Jr. ROTC and were led by a Grandson of the deceased veteran. The Mortuary of record was McMillan Mortuary of St. George, Utah.

Tuesday, July 17, 2018 at 7:30 PM at the Pine View High School Baseball Diamond the American Legion provided the "Color Guard" for the American Legion baseball game between the Dixie American Legion team and our St. George Sentinels. The Color Guard consisted of Color Guard NCOIC Foster Johnson, Bugler Gerry Gorsegner, Rifleman Terry Dunne, Rifleman Bodie Bodenhamer, U.S. Flag Commander Marti Bigbie, Utah Flag Jim Webb, and the American Legion Flag was carried by Don Oborn. Foster Johnson led those in attendance in the Pledge of Allegiance to our Flag and to the Republic for which it stands. Bugler Gorsegner played "To the Colors" and never sounded better.

Monday, July 16, 2018 at 8:30 PM at the Dixie High School Baseball Diamond the American Legion Color Guard presented the Colors prior to the start of the American Legion Baseball Game between Roosevelt, Utah and our St. George Sentinels. As the Roosevelt players lined up on the first base line and our St. George Sentinel players lined up on the third base line the American Legion Color Guard marched onto the baseball diamond. The American Legion Color Guard was led by Foster Johnson who expertly handled all the necessary commands while Marti Bigbie carried our Stars and Stripes Flag, Bodie Bodenhamer handled the Utah State Flag and Terry Dunne carried the American Legion Flag.
